

General Terms and Conditions Membership

BeeVee Article 1. Definitions

1. BeeVee: the Nijmeegse (medisch) Biologen Vereniging (Nijmegen (Medical) Biologists Association), linked to Radboud University in Nijmegen.
2. Membership: the various types of membership listed in articles 5 and 6 of the articles of association of BeeVee. 'friend of BeeVee' is a special type of membership of BeeVee in accordance with article 6.3 of the articles of association of BeeVee. A further subdivision of membership for members as defined in article 5.2 of the articles of association exists in the house rules of BeeVee, leading to year members and study members.
3. Association's year: an association's year is from 1 September to and including 31 August.

Article 2. Applicability

1. These general terms and conditions membership of BeeVee apply to: annual members, study members, honorary members, members of merit (hereafter referred to as 'members') and friends of BeeVee. Memberships can be realised pursuant to the procedure stated in the house rules
2. Deviations from and additions to these general terms and conditions membership are only valid if these have been drawn up in writing by the board and have been approved by the general meeting of members (GMM).
3. If any terms and conditions in these general terms and conditions membership contradict the house rules, then the terms and conditions of the house rules take precedence.

Article 3. Details study association

1. The association looks after the interests of its members in the broadest sense of the word, as described in article 4 of the articles of association.
2. The statement personal information must be signed in order to become a member.
3. The discount given on study materials and study books only applies to members (except friends of BeeVee) as specified in article 2.a of the articles of association of BeeVee.
4. On the website of study association BeeVee (www.beevee.nl), LinkedIn page of BeeVee and in the newsletter photos and/or videos of members can be posted, unless the relevant member specifies otherwise. Photos and/or videos can also be posted on social media, unless the relevant member specifies otherwise.
5. Each association year an almanac is published by MOTJE et Al., a fixed activities committee (FAC) of BeeVee. This almanac includes a photo and personal information of a member, unless the relevant member specifies otherwise. Besides this photo, also more pictures of the member can be used for the almanac.
6. During each association year a list is drawn up of members who are younger than eighteen years old. This list is used for activities during which BeeVee serves alcohol. Members under eighteen are forbidden to purchase and consume alcohol during BeeVee related activities. Other provisions regarding the sale of alcohol can be found in the alcohol policy of BeeVee.

7. The member administration of BeeVee lists information described in the statement personal information of BeeVee.
8. Friends of BeeVee who study can use the website of BeeVee when they have obtained the board's permission thereto. In doing so, they have the same rights and duties as the members.
- 45 9. Provisions regarding placing orders of study materials in the webshop can be found in the general sales terms and conditions of BeeVee.

Article 4. Performance Assignment

1. All members have the rights of a member as described in the articles of association.
- 50 2. Members must always handle the material of BeeVee discretely and with care. This involves information and media on the website and GMM documents.
3. Members must always handle the property of BeeVee discretely and with care.
4. The board has the right to approach members on the non-compliance of the general terms and conditions membership and to take suitable measures. These measures are described in articles
55 6, 8 and 9 of the articles of association.

Article 5. Payments

1. A member must always pay the means or products supplied by BeeVee if there are costs involved.
- 60 2. A member of BeeVee has financial obligations as described in article 34 of the house rules.
3. The treasurers and chairmen of committees can file their expenses with the treasurer of BeeVee. These activities can be filed up to two months after the relevant activity has been completed. The financial year is divided into two 6-month periods. The first half year runs from the 1st of January to and including the 30th of June, whereby expenses can be filed until 31st of July. The second half
65 year runs from the 1st of July to and included the 31st of December, whereby expenses can be filed until the 24th of December.
4. Please refer to the general sales terms and conditions for specifications with regard to orders made via the BeeVee web shop.
5. If a member has not paid after a reminder, then the member can be suspended as described in
70 articles 6,8 and 9 of the articles of association. It is also possible to send a debt collection; any costs incurred in this respect are to be fully paid by the member of the association.

Article 6. Liability

- 75 1. BeeVee is liable for the members as detailed in the special terms and conditions of the liability insurance of BeeVee.
2. Study Association BeeVee is not liable for theft of and/or damage to property of those present during activities of BeeVee.
3. BeeVee is not liable for damage to third parties.
- 80 4. BeeVee is not liable for:

- a. suffering by members or third parties as a result of incorrect or incomplete data or information provided by members to BeeVee or is the result of any act or failure to act of members;
- b. suffering by members of third parties as a result of the act or failure to act of assisting persons engaged by BeeVee (except members), even if they are a member of an organisation associated with BeeVee;
- c. professional, industrial or consequential damage suffered by members of third parties.

Article 7. Termination

1. The membership can always be terminated without observing a notice period. Payments made are not repaid by BeeVee as described in articles 6.5, 8.9 and 9.1 of the articles of association.
2. Upon termination of the membership the terms and conditions of the membership of the association will lapse, provided the payment obligation has been complied with.
3. The notice must be given in writing or electronically.
4. Termination of the membership can be realised in accordance with the provision in article 6 of the articles of association.

Article 8. Final provisions

1. After agreeing with the general terms and conditions membership, a member must comply with these terms and conditions.
2. Any cases not provided for in these general terms and conditions membership, or involving a difference of opinion with regard to the content of the provisions of these terms and conditions, will be settled by the board. If necessary a GMM will be organised.
3. The general terms and conditions membership cannot contradict the articles of association of BeeVee and the house rules.
4. The general terms and conditions membership immediately takes effect after approval by the GMM, provided this has been documented in writing.

The abovementioned general terms and conditions membership have been determined on general meeting of members held on the 5th of May 2024 and have been signed by the chairman and secretary of the association.
